
340B in Florida

Key Points

- Florida's low-income taxpayers are required to utilize for-profit pharmacies in California.
- PBM and for profit chain drug stores have the most number of contracts benefiting from federal program intended to support needy Florida taxpayers.
- Half of the contract pharmacies intended to serve poor patients in Florida are located in affluent neighborhoods.
- Florida 340B hospitals (4.1%) provide more charity care than the national average (2.28%).

25% of 340B contract pharmacies for the top Florida hospitals with the most contract pharmacies are based outside the state. Some of the pharmacies are in California.
