PIONEER HEALTH

- Maryland's low-income taxpayers are required to utilize for-profit pharmacies in Hawaii and California.
- Pharmacy Benefit Management (PBM) owned and chain drug store contract pharmacies benefit from a federal program intended to support low-income Maryland taxpayers.
- More than half of contract pharmacies intended to serve poor patients in Maryland are located in affluent neighborhoods.
- Maryland 340B hospitals (0.62%) provide less charity care than the national average (2.28%).

50% of 340B contract pharmacies for the Maryland hospitals with the most contract pharmacies are based outside the state. Some of the pharmacies are in Hawaii and California.
