- South Carolina's low-income taxpayers are required to utilize for-profit pharmacies in California.
- For profit chain drug store has the most number of contracts benefiting from federal program intended to support needy South Carolina taxpayers.
- 55% of the contract pharmacies intended to serve poor patients in South Carolina are located in affluent neighborhoods.
- South Carolina 340B hospitals (4.33%) provide more charity care than the national average (2.28%).

43% of 340B contract pharmacies for the top South Carolina hospitals with the most contract pharmacies are based outside the state. Some of the pharmacies are in California.
